# 2 OVERVIEW

The OPC Alarms and Events Integration Module allows alarms and events from an OPC Alarms and Events Server to be integrated into the IndigoVision system. This document explains how to install and configure the OPC Alarms and Events Integration Module.

## Compatibility

Please ensure you have properly installed, configured, and licensed an OPC Alarms and Events Server.

## OPC

The OPC Alarms and Events Integration Module is compatible with OPC Servers that support OPC Alarms and Events 1.10 specification.

## System Requirements

The OPC Alarms and Events Integration Module can be installed on any of the following Windows® operating systems with the latest service packs applied:

- Windows® 7 (32-bit)
- Windows® 7 (64-bit)
- Windows® Server 2008 R2

If a firewall is enabled on your system, ensure that the integration module executable, **ivopcaec.exe**, is added to the list of exceptions.

## Network Video Recorders

The OPC Alarms and Events Integration Module cannot be run on the same PC as an IndigoVision Network Video Recorder – Alarm Server (NVR-AS).

An exception to this rule is when the IndigoVision NVR-AS is not licensed and therefore requires no USB license dongle. In this case, the IndigoVision NVR-AS is used solely as an IndigoVision Alarm Server.

## Licensing

The OPC Alarms and Events Integration Module is a licensed product. A correctly licensed USB dongle must be present on the system running the OPC Alarms and Events Integration Module.

## INSTALLATION

To install the OPC Alarms and Events Integration Module:

1. Insert the IndigoVision Integrations DVD, or download the module from the partner extranet site.
  - ▶ For more information, see *"References" on page 5*If you are using the Integrations DVD, navigate to **ControlCenterIntegrationModules\OPC\OPC Alarms and Events**.
2. Run **setup.exe** and follow the on-screen instructions.

By default, the OPC Alarms and Events Integration Module is installed to:  
**C:\Program Files\IndigoVision\Integration\OPC Alarms and Events Integration Module. C:\ProgramFiles (x86)** for 64-bit operating systems.
3. Edit the system configuration file (**System.conf**).
  - ▶ For more information, see *"System configuration file (System.conf)" on page 13*This file is shown during installation. Edit the system configuration parameters. Save and close the file.
4. Edit the To IV Alarm Server list configuration file (**TolvAlarmServers.conf**).
  - ▶ For more information, see *"To IndigoVision alarm servers configuration file (TolvAlarmServers.conf)" on page 14*This file is shown during installation. Specify the To IV Alarm Servers and their corresponding Tolv mapping files. Save and close the file.
5. Edit the OPC event configuration file (**Tolv.conf**).
  - ▶ For more information, see *"Alarms to IndigoVision configuration file (Tolv.conf)" on page 14*This file is shown during installation. Specify the mappings of the OPC Alarm and Events names to the IndigoVision alarm IDs. Save and close the file.
6. Edit the TolvAlarmActions configuration file (**TolvAlarmActions.conf**).
  - ▶ For more information, see *"To IndigoVision alarm action configuration file (TolvAlarmActions.conf)" on page 14*This file is shown during installation. Specify the mapping between Alarm Actions on event sources and Zone Name to action. Save and close the file.
7. Edit the Categories configuration file (**Categories.conf**).
  - ▶ For more information, see *"Categories configuration file (Categories.conf)" on page 14*This file is shown during installation. Specify the category event numbers for event types that you are interested in receiving. Save and close the file.
8. Start the OPC Alarms and Events Integration Module service from the Windows® services.



# 4 UPGRADING

If you have an existing OPC Alarms and Events Integration Module installation, an upgrade is required.

When upgrading from version 1.00 to 1.10, the following files are different and need to be updated:

- ***Tolv.conf***
- ***System.conf***

## Tolv.conf

For version 1.10, the format of the default ***Tolv.conf*** file is changed to support the Control Center suite.

The ***ConfigConverter*** tool upgrades the ***Tolv.conf*** file automatically as part of the installation process and upgrades any Tolv entries found in the old ***Tolv.conf*** file.

The ***configconverter.exe*** is located in the Integration Module installation location. The executable can be run at any time by an administrator to convert any additional ***Tolv.conf*** files for additional alarm servers. During conversion any errors are listed in a log file. The log file can be found in the ProgramData directory for the integration module.

## System.conf

For version 1.10, the ***System.conf*** file has an additional section on Alarm Actions. Also BMOOnline and BMOOffline entries have been renamed to IMOnline and IMOffline.

The ***System.conf*** file is not updated during the upgrade process.

To update the ***System.conf*** file an administrator has to copy the additional section from the sample ***System.conf*** and add it to the existing ***System.conf*** file. The sample ***System.conf*** file can be found in the installation directory.



# 5 CONFIGURATION

This chapter describes how to configure the OPC Alarms and Events Integration Module.

## Integration module

To integrate OPC Alarms and Events Server into IndigoVision Control Center you must configure the following:

1. Edit the system configuration file (**System.conf**).

2. Configure the list of Tolv IndigoVision alarm servers that receive OPC Alarms and Events (**TolvAlarmServers.conf**).

3. Configure the events of interest (**Tolv.conf**).
  - ▶ For more information, see "*Alarms to IndigoVision configuration file (Tolv.conf)*" on page 21
4. Configure the Alarm Actions of interest (**TolvAlarmActions.conf**).
  - ▶ For more information, see "*Alarms Actions to IndigoVision configuration file (TolvAlarmActions.conf)*" on page 22
5. Configure the Categories of interest (**Categories.conf**).
  - ▶ For more information, see "*Categories configuration file (Categories.conf)*" on page 23
6. Define the OPC Alarms and Events of interest within Control Center.

## System configuration file (System.conf)

The system configuration file provides the Integration Module with system information such as the name and location of the OPC Server, configurable Integration Module status events and Tolv Alarm Actions.

## To IndigoVision alarm servers configuration file (TolvAlarmServers.conf)

This file contains a list of Alarm Server IP addresses. Each Alarm Server has a mapping to a Tolv configuration file. This can be the default Tolv.conf configuration file. It is possible to map multiple alarm servers to the same Tolv file and to map a single alarm server to multiple Tolv files.

## Alarms to IndigoVision configuration file (Tolv.conf)

This file contains the mapping between the OPC alarms and events and the IndigoVision external system input. It contains the data that maps the event received from the OPC system to the IndigoVision system.

## To IndigoVision alarm action configuration file (TolvAlarmActions.conf)

This file contains the mapping between the OPC alarm action sources and the ZoneName / Alarm Server IP address.

It contains the data that maps an alarm action on the OPC system to the IndigoVision zone that is actioned.

This configuration file is only required when the required alarm action is not represented as an event in the **Tolv.conf** file. This is typically only required when used with the OPC Alarms and Events Integration Module to provide alarm acknowledgment support for the Gallagher Command Centre.

## Categories configuration file (Categories.conf)

This file allows an administrator to specify the category event numbers for event types that you are interested in receiving. This filters the event types that are sent by the OPC system to the Integration Module.

## IndigoVision Control Center configuration

All the OPC Alarms and Events of interest and the IMOnline, IMOffline, 3rdPartyOnline, and 3rdPartyOffline alarm IDs as defined in the system configuration file must be configured in Control Center.

**Create a new external system**

The IP address entered is the IP address of the host running the integration module.

**Create a new zone and external detector**

Add a new zone for each unique alarm that must be reported in Control Center.

Within the zone create a new external detector for the external system above with the external event ID of the event configured in the Tolv file of the Integration Module.

It is recommended that the zone name description configured in Control Center closely matches the OPC Alarms and Events Server event name. This will help to ensure there is no confusion in correlating events.





# 6 SYSTEM CONFIGURATION FILES

This section contains examples of the configuration files required by the OPC Alarms and Events Integration Module.

## System Configuration File (System.conf)

This file lists the configurable system parameters that are independent of alarms and events. The usage of the parameters listed in the sample configuration file below is explained in their comments:

## To IndigoVision alarm servers configuration file (TolVAlarmServers.conf)

This file contains a list of IndigoVision TolV Alarm Server IP addresses that receive OPC alarm and events. Each Alarm Server IP address is associated with an Alarms To IndigoVision configuration file.

All entries should include a valid IP address. Anything written after # is treated as a comment.

The installation provides one alarm actions to the IndigoVision configuration file. The file is called ***TolvAlarmActions.conf***.

There is one mapping entry per line in the mapping file. Each entry is a comma-separated pair.

## Categories configuration file (Categories.conf)

The installation provides one alarm actions to the IndigoVision configuration file. The file is called **Categories.conf**.

There is one mapping entry per line in the mapping file. Each entry is a comma-separated pair.

## EVENT CONFIGURATION

OPC alarms and events can be mapped using a number of the fields of the OPC OnEvent notification method which is documented in the OPC Alarms and Events Specification v1.10.

Mapping is flexible. For example, to map all event notifications for a particular source such as a door, simply specify the source name. Or, where two events share the same source name and category, but only differ by the message string, specify the source, category, and a message substring search phrase.

The following table maps the Tolv configuration field to the OPC OnEvent notification field as defined in the OPC Alarms and Events Specification.

**Table 1:** Mapping Tolv configuration fields to OPC OnEvent fields

Field No.	Field	Type	OPC OnEvent field	Description
1	Event ID	Int	N/A	The Control Center external system input number (between 1 and 32767).
2	Source	String	szSource	The alarm/event source.
3	Category	Int	dwEventCategory	The alarm/event category.
4	State	String	wNewState	Leave blank to map when the alarm/event becomes active. Use inactive to map when the alarm leaves the active state. Use acked to map when the alarm is acknowledged.
5	Message substring	String	szMessage	A word or phrase in the event notification message.
6	Description	String	N/A	A description of the event (this may be imported into Control Center using the ImportAlarmSources tool).

The rules for mapping OPC event notifications to IndigoVision events are as follows:

1. Duplicate event ID numbers are allowed.  
Two OPC Alarms and Events can map to the same external alarm source in Control Center.
2. System event ID numbers defined in the System configuration file must not be used in this file.  
The Integration Module will check for conflicts when it starts and logs an error and notifies the user before exiting.
3. Either the source or the category fields must be defined.

When an OPC event notification is received, including alarms with their various state and condition transitions, the Integration Module searches the mappings from the event configuration file for possible matches.

The integration module prefers more specific mappings over general mappings (blank fields). The order in which the integration module treats mappings as a match is defined in the following table.

**Table 2:** Order of integration module match mappings

## ALARM ACTION CONFIGURATION

The OPC Alarms and Events Integration Module allows administrators to configure alarm actions sent from an OPC Alarms and Events Server to Control Center. This allows the alarm state of the OPC Server to be represented in Control Center.

There are two types of alarm action that can be sent, acknowledged and cleared. The alarm actions can be configured using one of these files:

- ***System.conf***
- ***Tolv.conf***
- ***TolvAlarmActions.conf***

### System.conf

The ***System.conf*** file has an Events section which enables administrators to configure alarm actions based on the Tolv events configured in the ***Tolv.conf*** file.

This is made up of an `EnableAlarmActionsToIv` flag which can be set to `true` if alarm actions are to be used. Also Acknowledgement and Clear parameters, which can be set with a resultant action, occur on Acknowledge or Clear.

When an alarm is received from an OPC system, a detector is triggered in Control Center using the rules defined in the ***Tolv.conf*** file. This detector is attached to a Zone which is put into an alarm state.

When you acknowledge or clear the alarm, the Integration Module checks the ***Tolv.conf*** file to determine which detector was triggered by the original event. The integration module then sends the alarm action to the zone that contains that detector.

### Tolv.conf

Administrators can configure `inactive` and `acknowledged` event notifications using the ***Tolv.conf*** file.

This allows administrators to explicitly configure which detectors are triggered when an alarm is acknowledged or becomes inactive. Also administrators can configure, in Control Center, the required action to take when the detector is triggered.

### TolvAlarmActions.conf

The ***TolvAlarmActions.conf*** file supports manually mapping the source of alarm actions to the Zones that should be actioned.

This allows administrators to manually map which Zones can be actioned from the OPC Server.

This is useful when the event that triggered the Control Center Zone to the alarm state is not represented by a Tolv event entry. For example, when using the OPC Alarms and Events Integration Module to send alarms and events from Control Center.

# 9 TROUBLESHOOTING

## Alarms not appearing in Control Center

If alarms are not appearing in Control Center then the following end-to-end check for a single alarm may help to determine the source of the problem.

1. Enable debug level logging.

Do this by setting `Level=debug` in the [Log] section of the system configuration file, then restart the OPC Alarms and Events Integration Module service. Allows the Integration Module to log all alarms and events received from the OPC Alarms and Events Server Alarms and Events server, not just those that have been mapped in the Alarms To IV configuration file.

2. Verify that the Integration Module is sending events to the nominated Alarm Server  
By opening the most recent Integration Module log file and check for messages stating that the alarm has been sent, for example:

```
2014-04-28 12:19:08 [system] Sending ToIv event 'Input 1:::' to Alarm Server
'172.16.129.177'...2014-04-28 12:19:08 [system] ToIv stateless event 'Input
1:::' sent to Alarm Server '172.16.129.177' with external input number '100'.
```

If the alarm is generated as expected go to step 3.

If step 2 does not identify that an alarm has been sent for the event of interest then look to see if the Integration Module is receiving the event but has not been configured, for example:

```
2014-04-28 12:15:32 [system] ToIv stateless event 'Indigo Vision Ltd -
Development:8::Licence Warning - Devices required to maintain your licence
validity are not responding' is not configured to send to Alarm Server
'172.16.129.177'.
```

If the event is not seen in the log file then refer to the documentation on how to set up and configure the OPC Alarms and Events Server Alarms and Events software.

If the event is seen in the log file then the Alarms To IV configuration file (*Tolv.conf*) is not correctly configured to forward this event to the Control Center suite.

3. Verify that the corresponding zones and external detectors have been created and that the zones have been set and the external detectors have been enabled in Control Center.
  - a. In the **Site Setup** mode select the relevant **Site** on **Alarms** explorer:
  - b. Click on the **External Systems** tab and ensure that an External System with the IP address of the PC running the OPC Alarms and Events Integration Module has been created.
  - c. Click on the **Zones** tab and ensure that a zone has been created containing an external detector with Input Number being the event number identified from step 2 above.  
Also ensure that the external system is correct. The external detector must be enabled and the zone must be set.
  - d. Right-click and select **Properties**.

- e. On the **Zone** tab ensure that the Alarm Server is the same as that configured in the ToIV Alarm Servers configuration (*TolvAlarmServers.conf*) file for the .  
Ensure that the zone belongs to the nominated Alarm Server.

## License Dongle Issues

If the OPC Alarms and Events Integration Module is installed on a machine that has not had Aladdin HASP software installed previously then no license dongle issues should be encountered.

However, possible issues may occur if the machine to be installed on has previously had Aladdin HASP software installed on it.

### How to Check that the Aladdin HASP Dongle is Active

If the Aladdin dongle is working correctly then a red LED is illuminated on the dongle.

Check that the device drivers are listed in Device Manager:

1. Navigate to **Control Panel > System**
2. Select the **Hardware** tab
3. Select **Device Manager**
4. Navigate to **Universal Serial Bus Controllers**, and expand the list.
5. Check that the following are listed:
  - Aladdin HASP HL Key
  - Aladdin HASP Key
  - Aladdin USB Key
